# F160/2024. Update on the Leaders role by Clir Jason Mockett.

The mayor's role is the Civic Role, the Leaders role in the main is the day-to-day administration and running of the office with the Clerk. This can take a lot of time up for the clerk, so it is useful for someone to be there to support the Clerk. We also get a fair amount of members of the public wishing to raise issues about councillors, they are advised by the Clerk of the correct procedure, if they do not wish to escalate to Fenland District Council, for example it could be councillors not calling residents back, or not being able to give the answers the resident wants. This is something that the Leader will assist with. The leader also works with the Clerk on the content of the agenda.

Cllr Mockett advised if anyone had any other questions to contact him directly.

#### F161/2024 Public Forum

To allow any member of the public to address the council. Time allowed 15 minutes in total to be split equally between the total amount wishing to speak.

Five members of the public were present.

Stephen Hodson – Can the police report be made public or some of the information.



Robert Windle – Offered comments for the future leader role – should be the best person for the job not just a member of the majority party. Moving forward could the leader initiate projects to promote the town, look at grants for outside bodies, look at best practice in other areas, why reinvent the wheel when others are doing it, set aims and goals where do we want the council to be in 6 months, 1 year, 2 years etc. How does the council look at this growth and how does it manage it.

Robert Windle – Disappointed why the allotment awards did not happen this year, or no community projects meeting since February. Commend the Town Clerk for organising an exceptional Remembrance Parade and it was a privilege to be part of it.

Robert Windle - Congratulations to Cllr Boden for his hard work giving regular updates on the Ralph Butcher Causeway and the pressure put on CCC to conduct the remedial works to get the B1040 reopened.

# F162/2024 Agenda items for Discussion.

- 1. Bower Footbridge Cllr Boden Intention of CCC highways to repair the Bower footbridge in next financial year 2025/26, however due to the cost of the repairs it will be more cost effective to replace. The Town council would be approached for a suitable date between 1<sup>st</sup> April 2025 31<sup>st</sup> March 2026. The summer may not be a great time, so the question would be do the Town Council have any opinion on what the best time of year would be. The Clerk to email Adam Cobb asking for the specification of the bridge, materials etc, also email all Cllrs and ask if they have any thoughts on closure. The Clerk to also advise Mr Cobb that there must be a platform to ensure disabled access.
- 2. LHI New Road School Cllr Mockett explained that New Road primary pretty much have zero health and safety outside the school, the yellow lines that are present were there prior to the school being extended, there are no yellow lines from Bellman's Road to the WTC allotment entrance, this is causing horrific parking issues at the start and end of the school day, there are no flashing lights warning light. The ward Cllrs have tried for two years to get CCC to install some safety measures, to date nothing has been done, there has now been a site meeting with CCC, and New Road School are submitting their own PFHI (Private funding highways improvements) for improvements to safety at the school, they are aware that that may be required to supply 10% when CCC undertake the work. They may also have to source some grant funding. CCC have requested that the school contact WTC and request their support for the initiative. Proposed by Cllr Mockett, seconded Cllr Wicks with a unanimous vote in favour.
- 3. LHI ClIr Gerstner Questioned why the LHI for High Causeway scored very poorly. Was the application not robust enough? ClIr Boden advised there was nothing wrong with the Clerks application, it has been misread by CCC who miscategorised and assuming it was for manual bollards/barrier despite the application clearly stating it needed to be automated and would be monitored by the CCTV control room. ClIr Wicks suggested as this had been mishandled, could WTC have two applications at this round, the primary one being High Causeway. The second being the layby in Coates where vehicles cut through to try and beat the traffic and gain a few metres. ClIr Boden proposed a letter be sent to Mr Stephen Moir Chief Executive CCC advising that in the interest of fairness we have two submissions, seconded by ClIr Wainwright with a unanimous vote in favour. ClIr Wainwright advised highways to have suggested speed bumps, or a chicane would not work, it would be better to close one end of the layby. ClIr Mockett proposed first submission would be for the automated bollards / barrier on High Causeway, the second to be the Coates layby. Seconded ClIr Laws. Unanimous vote in favour.
