This refers to the developer Allison Homes providing a combined cycle/footpath on Drybread Road. In which the road width is to be 6.7 metres wide. Now that the kerb and culverts have been installed, the road width has been reduced to 5.5 metres.

The matter has been referred to Andrew Dudley, Senior Enforcement Officer—consultant Fenland District Council. He responded to me, saying the works are controlled and covered under an S278 agreement with CCC Highways. I requested whether these works are agreed upon, and he will report back (03-03-2025).

My message to the WTC planning committee:

- 1. If the works have been carried out following an agreement with C.C.C. why is nobody in WTC or any residents aware?
- 2. If the works do not comply this will cause further inconvenience to residents opposite this development when alterations are undertaken.
- 3. Why have the extended road works involving one-way traffic not been completed on time? Resurfacing has not been completed indeed, it has not been started.
